Hear Ye, the following:

## **1. Times at which the Senate is in session**

---

The Senate will be in session from April 15<sup>th</sup> 2019/XL as per Standing Rule 1. The Mençei-elect will decide whether or not a recess will be taken between the election of a Mençei and the beginning of the First Cosa.

## **2. Result of recent votes**

The following bills received Royal Assent and have been signed into law:

The following bills received Royal Veto:

*Introduced by Viten Marcianiis (MC-FreeDem), Distain*

### **52RZ17– The Covenants of Rights and Freedom [Amendment]**

*Introduced by the Most Hon. Ian Plätschisch (Senator-MM), Seneschal, representing His Majesty's Government*

## **5. Business of the Committee on Rules and Administration**

---

The committee is dissolved, pending presentation of a motion to establish it for the duration of the 53<sup>rd</sup> Cosa.

## 6. Other Business of the Senate

---

The following people have joined the Senate through election:

- **Viteu Marcianüs**, as Senator for Vuode,  
for a full term of two Cosas ending on approx. October 15<sup>th</sup> 2020/XLI
- **Thor Deyaert**, as Senator for Cézembre,  
for a full term of three Cosas ending on approx. July 15<sup>th</sup> 2021/XLII
- **Ieremiac'h Ventrutx**, as Senator for Florencia,  
for an interim term ending on approx. January 15<sup>th</sup> 2020/XLI

Pursuant to Rule 4, the updated list of Senators by seniority is as follows: da Schir; Pinátsch; Valcadac'h; Siervicül; Plätschisch; Ventrutx; Marcianüs; Deyaert. A three way tie was broken using the first tiebreaker as follows: Clarks served by S:r Ventrutx in the Senate, 33; Clarks served by S:r Marcianüs in the Senate, 30; Clarks served by S:r Deyaert in the Senate, 0.

The Senate will elect a Mençei (Lord President) for the 53<sup>rd</sup> Cosa as per Rule 2. Nominations can be lodged between the 15<sup>th</sup> and the 22<sup>nd</sup> of April; if by the end of the period no single Senator is nominated by a majority (5) of duly seated Senators, an Instant Runoff Vote ballot will be held between all nominees.

## 7. Communications of the Acting Mençei and final remarks

---

As per Rule 2, the Dean of the Senate (Sen. da Schir) is performing the duties of the Chair pending the election of a Mençei.

It is advised that Senators visit the Senate's working threads to stay up to date on any motions that may be presented later on in the month.

The Government will take written questions (Terpelaziuns) all month long as usual.
