

Rotary Club of Wooster Art Scholarship Application

Section A. Purpose

This art scholarship originates from net proceeds received by the Rotary Club of Wooster from its annual participation in the Wooster Arts/Jazz Fest and is designated to provide financial assistance to the selected applicant to offset their college tuition expenses.

Section B. Scholarship Requirements

To be eligible, each applicant must:

- Be a current graduating senior of Wooster High School (WHS) with a minimum 3.00 GPA.
- Submit official WHS transcripts of grades.
- Submit a resume that highlights past experiences and participation in visual and/or performing arts along with a statement of how the applicant would use the scholarship.
- Submit the completed application on or before March 26, 2014 to their assigned WHS Guidance counselor.

Section C. Scholarship Evaluation

All applications will be evaluated by a scholarship committee consisting of members of the Rotary Club of Wooster Ohio.

Section D. Financial Considerations

While this scholarship is not primarily based on financial need, the applicant may want to have the scholarship committee consider any special financial circumstances (low or loss of family income, unique family debts, illness, etc.) in their evaluation. *The financial information form (located on the reverse side of this form) must only be filled out if financial need is to be considered.*

Section E. Notice to Applicants

In accordance with its philosophy of public service, the Rotary Club of Wooster, Ohio recognizes that anyone that meets this scholarship's eligibility requirements may apply regardless of race, religion, gender, or ethnic background.
