

THE BEULAH SIEGEL SCHOLARSHIP

2015 APPLICATION

One or more scholarships may be awarded to a Wayne County resident who will be a graduate of the Wooster High School Class of 2015. This scholarship will be awarded to an applicant or applicants who, **because of financial need**, might otherwise not be able to obtain full time education or vocational training beyond high school.

Tuition and fees beyond resources made available to the student will be paid by this award. In addition, up to a maximum of \$1500 per year may be paid for course and lab fees, books, school and/or lab materials, computers, computer supplies and other items required by courses of instruction. The Wayne County Community Foundation will pay all items including tuition directly to the school. Room and board, personal expenses and travel cannot be provided.

This scholarship is renewable annually until attainment of a degree or completion of vocational training, for up to four years, whichever comes first; upon satisfactory completion of all academic requirements and good conduct, all of which are at the sole discretion of the selection committee.
