

## **END USER LICENSE AGREEMENT for WPT 05 - Portuguese Web of 2005**

accepts to use partially or in its totality the WPT 05 collection - Portuguese Web of  
2005, gathered by the XLDB Research Team of the Lasige Group of the Faculty of  
Science of the University of Lisbon and made available by Linguateca-XLDB, to conform  
to the following terms and conditions:

- The user can install the WPT 05 on a hard drive or any other storage medium,  
or in file server in an informatics network, for the purpose of:
  - permanent installation in hard drive or in other storage medium
  - use of the WPT 05 in the user's internal network
- The user can create backups of the WPT 05, which are subject to the same terms  
and conditions.
- The user can use the WPT 05 for education, evaluation, research and  
development purposes in the areas of Natural Language Processing, Information  
Retrieval or Document Recognition Systems, being its use forbidden for  
commercial purposes, direct or indirectly.
- Direct commercial purposes: the selling of part or the totality of the WPT 05 in  
its original format or in an altered format. Indirect commercial purposes: the  
marketing of products that use WPT 05, documents extracted from the WPT 05  
(such as mailing lists, article texts, among others) or any kind of software that  
uses the WPT 05 or modified versions of the WPT 05 for operating.
- The WPT 05 can be reached by collaborators related to the Company / Entity  
above mentioned, provided that they are included in the research & development  
projects that cover the use of the WPT 05.
- The access to the WPT 05 is forbidden to others users that do not comply with  
the requirements previously mentioned, unless consent from Linguateca-XLDB is  
previously obtained.
- It is expressly forbidden to make copies or reproductions of WPT 05 to any  
server or location with the objective to be further reproduced or redistributed.  
The distribution of copies must be requested to Linguateca-XLDB.
- The user may modify the information of WPT 05 provided that those  
modifications serve exclusively the purposes of research and development above  
described, and that those modifications stay inside the Company / Entity.
- Small summaries, analysis or interpretations can be provided to the public or  
published in technical or scientific context, exclusively with the purpose of  
describing the research and development produced using the WPT 05. However,

the user must be aware of the third-party rights that may cover the provided content.

- Publishing any research or development document that had the WPT 05 as its research base must cite both Linguateca-XLDB and the XLDB Group, as the providers of the WPT 05 collection, in the following format:

  - Additionally, two royalty-free copies of the document must be sent, one to Linguateca-XLDB and the other to the XLDB Research Team.
- The XLDB Research Team and the Linguateca-XLDB cannot be held responsible for the content included in the WPT 05, since those contents are the result of a crawl from the Web and, as such, written by persons foreign to the XLDB Research Team and the Linguateca-XLDB.
- In any situation, the XLDB group and the Linguateca-XLDB are not responsible for transmission problems, fault or failure that occurs in the communication from and to the user.
- When using the WPT 05, the user agrees neither the XLDB Research Team nor the Linguateca-XLDB shall be liable for any damages or loss whatsoever provoked by the use, direct or indirectly, of the collection.
- Any failure of the utilization's conditions grants the right to the XLDB Research Team and to the Linguateca-XLDB the right to prosecute judicially against the offender.
