



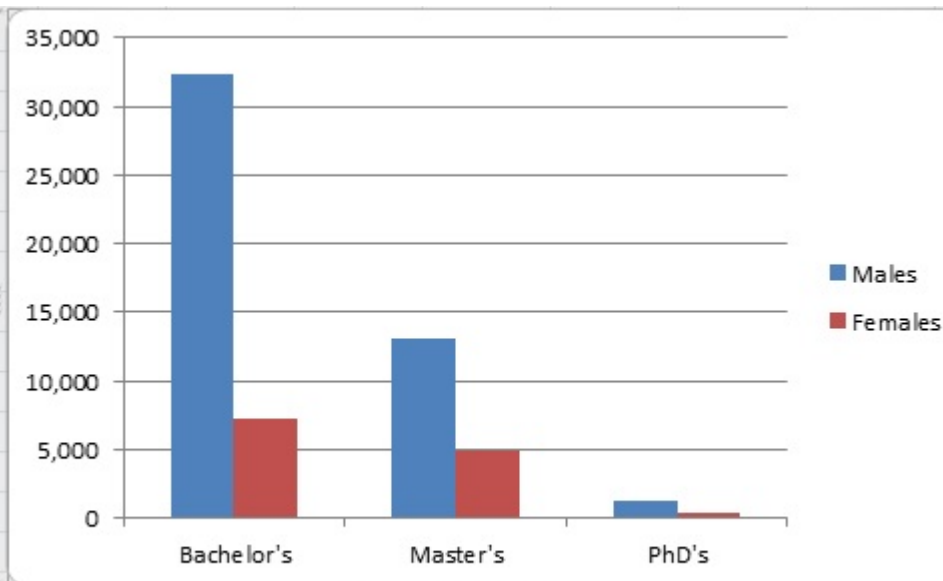

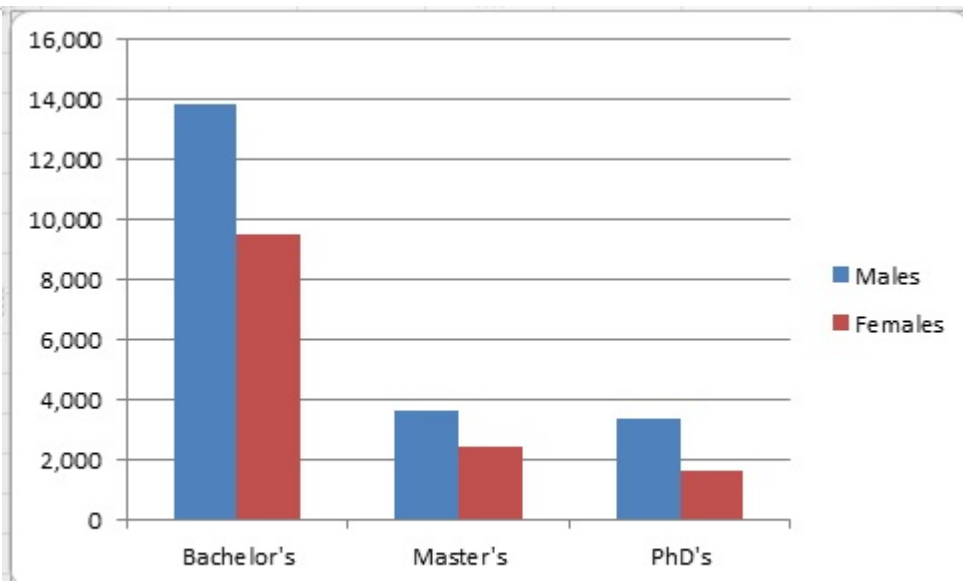

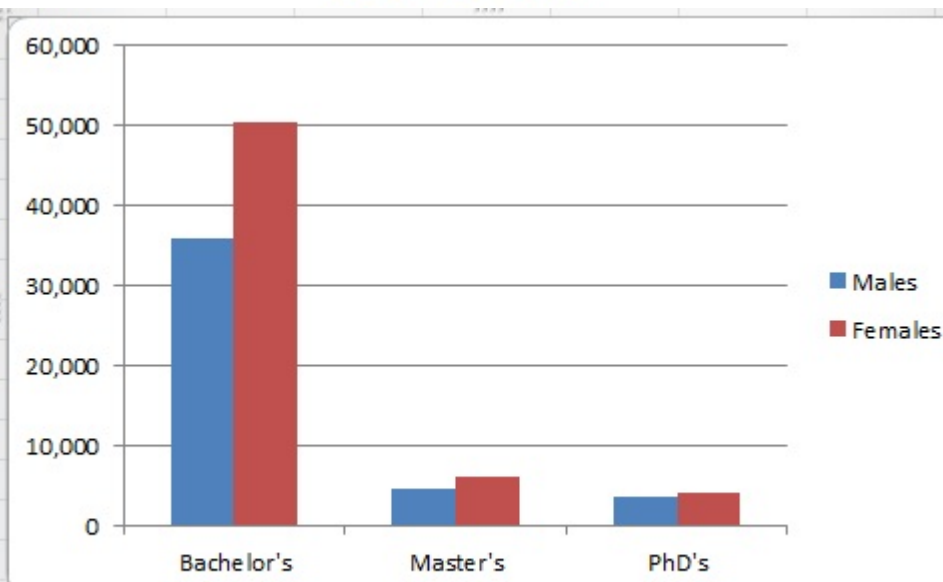
# 2009-2010 미국 대학의 졸업자 현황



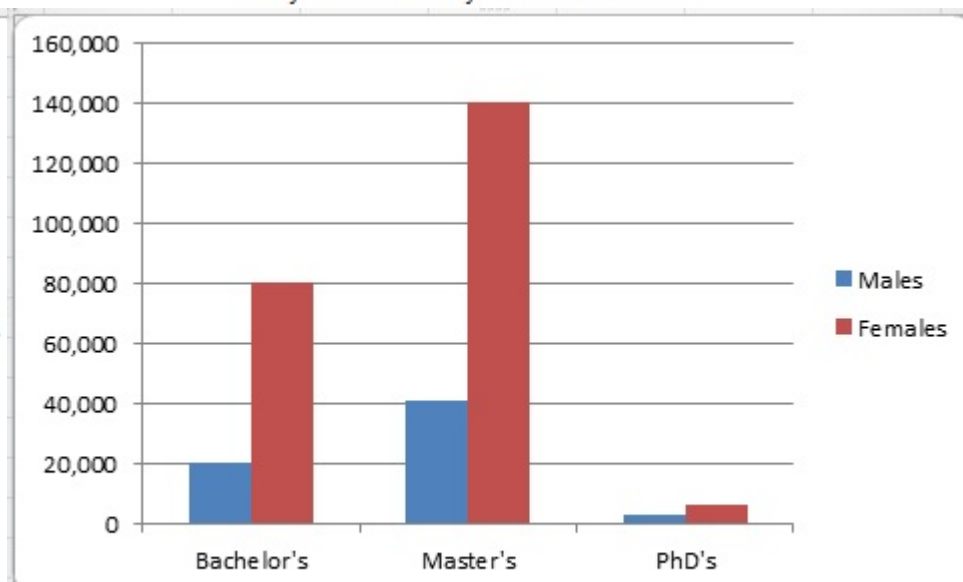

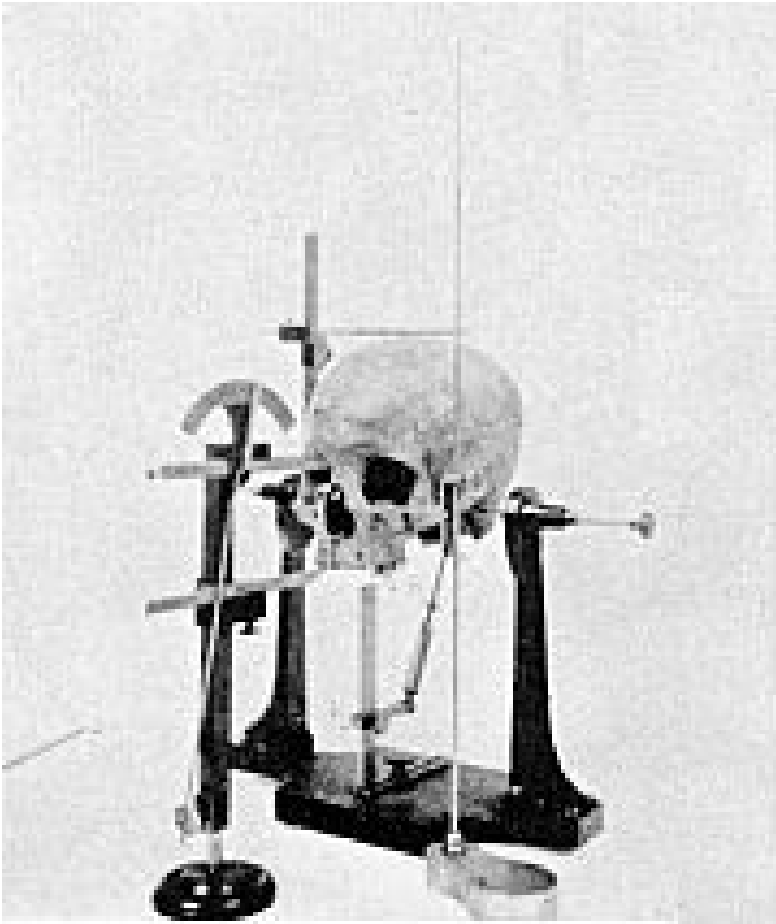


*Fig. 2: from left to right, comparative facial angle in monkey,

- 과학자 사회가 남성중심적인 편견을 가지고 있다면, 그들에 의해 확립된 이론은 세계가 작동하는 방식이 아닌 자신들의 편견에 의해 결정된 것일 수 있지 않겠는가?

# 주의할 점

---

- 여성적 대안 가설이 참이라는 뜻 아님!
- 남성들이 고의로 꾸며냈다는 뜻 아님!
- 남성적인 과학자사회 내의 암묵적인 편견들이 소위 '객관적' 과학적 지식 뒤에 숨어있을 수 있다는 뜻임!

# 객관성에 대한 전통적 입장

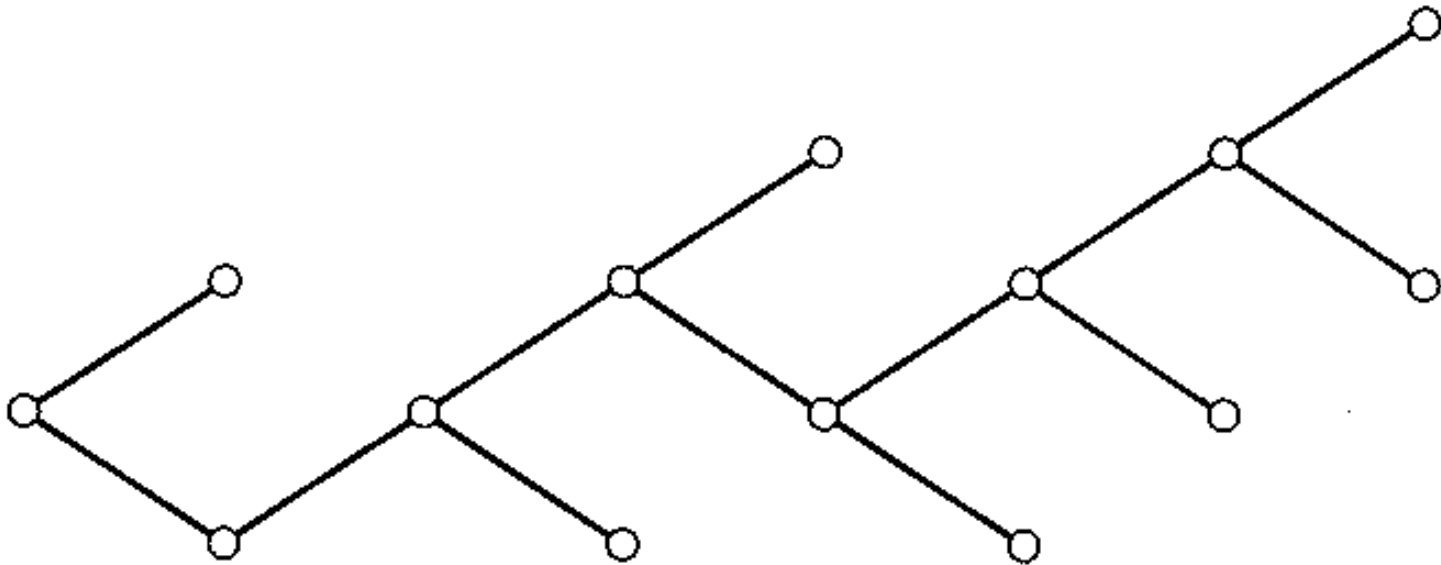
---

- 발견의 맥락에서 어떤 사회적, 심리적 요인이 개입되더라도, 정당화의 맥락에서 이루어지는 가설에 대한 시험이 그러한 요인들을 제거할 수 있다.

# 가설 생성과 시험에 대한 재고

---

1. 가설의 시험은 항상 대안가설을 상대로 이루어짐
2. 이론 선택의 궤적은 아래와 같은 그림을 따름



## 표준적인 가설 시험의 과정을 통해 과학의 내용에서 사회적 영향은 차단될 수 있는가?

---

- 이론 생성에서의 영향을 인정한다면, 이미 생성된 대안 가설 사이에서밖에 이루어질 수 없는 아무리 엄격한 이론 시험 방법으로는 그 영향을 차단할 수 없다.
- 성차별적이지 않은 대안 가설이 생성되지 않는 한, 시험을 통과한 이론은 최선의 성차별적 이론일 것이다.



# 암묵적 배경이론과 보조가설

---

- 자료를 이론의 증거로 간주할 때, 많은 암묵적 배경이론과 보조가설들이 사용되지만, 많은 경우 이들의 존재는 그와 경쟁하는 대안 가설이 나타난 후에만 인식.

# 우리에게 남은 선택지는?

---

- 이론 평가의 기준이 사회적 요인에 의해 오염되어 있지 않다 하더라도, 사회적 가치는 과학의 내용에 스며들어 있을 수 있다.
1. 합리성의 적용 영역을 제한하고, 과학의 객관성에 대한 주장은 약화해야
  2. 합리성의 모델을 이론 생성의 맥락까지 포함시킬 수 있도록 확장해야

# ‘객관적’ 과학을 위해서는?

---

- 주의 깊게 편견을 버리고 가설을 세워야 한다?

# ‘객관적’ 과학을 위해서는?

---

- 오히려 편향의 존재 가능성을 인정하고, 다양한 편향에 기초한 가설이 나오도록 권장해야.
- 그러한 여러 대안 가설을 인지할 수 있는 과학자 공동체는 그렇지 않은 공동체보다 인식론적으로 우월!

# 대안 가설의 중요성

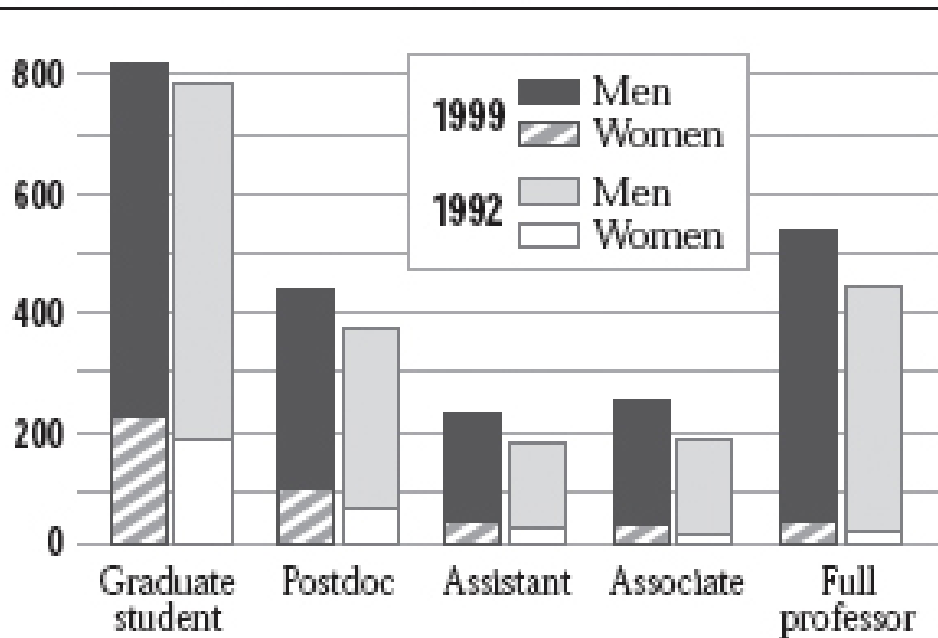
---

- 대안 가설의 존재를 모른 상태에서는 (한쪽 편향에 기초한) 기존 가설을 입증된 이론처럼 간주하기 쉽다!
- 대립하는 편향에 기초한 대안 가설이 있어야만, 기존 가설에 대한 더 엄격한 시험을 고안할 수 있다!

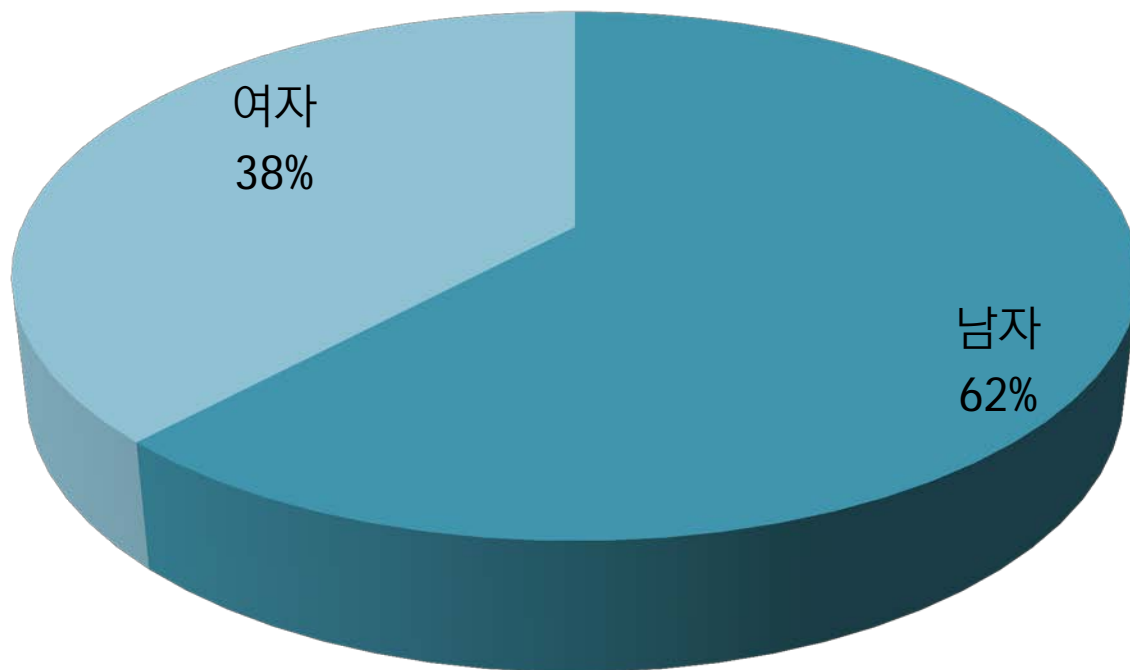
