1. Rendition of Fitness Reports. The Bureau has noted a tendency upon the part of reporting seniors to delay the rendition of fitness reports of officers far beyond the date when they should be submitted. It is, therefore, requested that fitness reports for the period ending 31 March, 1926 be forwarded as soon thereafter as possible. A large number of officers are to be examined for promotion in April and May and it is necessary that a complete file of fitness reports in each case be available in order that the Examining Board may make its report.

Furthermore, a line Selection Board is to be convened within the next few months and reports are necessary in order that the Selection Board may have complete information to guide it in its deliberations".

2. Beneficiary Forms attached to Officers' Fitness Reports. In connection with the Beneficiary Forms which are attached to officers' Fitness Reports, attention is invited to the fact that it frequently happens that these forms contain the name of a dependent not previously designated, such as father, mother, or some collateral relative, and that dependents previously designated, such as a wife and children, are omitted. Obviously, in most of these cases it is the intention of the officer to add the name of an additional dependent to those previously designated. The correct procedure in such cases, that is, when it is desired to add the name of a dependent not previously designated or to omit one, is to fill out the form completely, naming therein only those individuals who are claimed as dependent

relatives. It should be understood that newly executed forms for designating beneficiaries are substituted for those submitted previously.

3. Promotion - Officers. It is estimated that officers whose signal numbers are as below will become due for promotion on graduation of the class of 1926 U.S.N.A.

Lieutenants signal Nos. 1529 to 1592 inclusive
Lieutenants (jg) signal Nos. 3239 to 3382 inclusive
Ensigns signal Nos. 4079 to 4419 inclusive

4. Bureau of Navigation Circular Letters - duplication of. Attention is called to the following excerpt from a letter received in this Bureau:

"Attention is invited to the fact that this office has recently been receiving copies of Bureau of Navigation Circular Letters from more than one office, resulting in an unnecessary waste of paper and duplication of work of handling, filing, etc."

The Bureau distribution of each Circular letter is noted on the bottom of such Circular Letter and the noting of this distribution by local distributing offices in districts or units of the Fleet would serve to eliminate the above complaint.

5. Interpretation of Paragraphs D-9105 and D-9107, Bureau of Navigation Manual 1925 - Provisions of Discharge. The following is quoted from a letter addressed to the Commanding Officer of a hospital:

"DISCHARGE. - An enlisted man may be discharged within three months of the date of the expiration of his term of enlistment plus any time lost through sickness or injury the result of his own misconduct.

An enlisted man has been absent during his enlistment due to injury or sickness resulting from his own misconduct, and he must therefore make up such time before his enlistment is completed. May he be discharged under the provisions of Article R-3601 (1) U.S. Navy Regulations, prior to the expiration of his enlistment as extended by the time he is required to make up?

The provisions of law quoted in General Order No. 231, page 12, paragraph 3, as amended by the act of 1 July, 1918 (40 Stat., 717, par. 2), has the effect of incorporating in the enlistment contract the condition that the date of the expiration of enlistment is to be postponed so many days as may be lost in excess of one day on account of injury, sickness, or disease resulting from the enlisted man's own misconduct. But an enlisted man does not lose the benefits reserved to him on an early discharge within three months prior to date of the expiration of his enlistment so postponed on account of time lost by absence due to injury, sickness, or disease due to his own misconduct.

In the case presented the date of the expiration of enlistment has been postponed from 15 July 1920, to 1 September, 1920, on account of 48 days' absence due to misconduct. He might have been discharged under the above regulation any time after 1 June, 1920.

6. Qualifications for Advancement to Chief and Petty Officer 1st.Cl.

Attention of the service is invited to Article D-5106, Bureau of Navigation Manual. In addition to the requirements of one year's service in rate there is now another requirement that a man must HOLD or HAVE BEEN RECOMMENDED FOR PERMANENT APPOINTMENT before he can be advanced to chief petty officer or petty officer first class. Thorough familiarity with this article will save a lot of unnecessary correspondence.

7. Navy Training Courses. Navy Training Courses covering the ratings of Fire-Controlman second-class, Fire Controlman first-class, and Torpedoman third-class, together with a course on Diesel Engines, are in the hands of the printers, and are expected to be ready for distribution within the next few weeks.

Training Courses "A to N", Apprentice Seaman, Ship's Cook third-class, Carpenter's Mate third-class, Torpedoman second-class, Blacksmith second-class, Aviation Machinist's Mates, Aviation Carpenter's Mates, and Aviation Riggers are in manuscript form and will be printed as soon as funds are available.

The reprint of Chapter V, Part D, of Bureau of Navigation Manual, 1925, covering the requirements for advancement in rating, has been received from the printers, and will be distributed as outlined in Bureau of Navigation News Bulletin #69.

Copy of report of the Commander, Destroyer Squadrons, Battle Fleet, indicates that training of enlisted personnel is being energetically carried on, with the use of training courses as a basis of instruction.

8. Motion Pictures. The instructional film "Care and Operation of Oil Fired Water Tube Boilers" being prepared by the Bureau of Navigation and Engineering is progressing satisfactorily. It should reach the Fleet while it is in southern waters. The film will contain, among other features, about

1500 feet of photography showing the proper way to build and repair boiler walls and floors. This part of the picture was taken at the Fuel Oil Testing Plant at Philadelphia and the work was done by the best man there under the supervision of the Officer-in-Charge of the Plant. The Bureau believes that this will be of valuable assistance to officers and men on all ships and stations.
