Of President Spencer, of Southern Railway Wreck and the President Killed.

Seven persons, including Samuel Spencer, president of the Southern Railway company, were killed at 4:45 o'clock on Thanksgiving morning in a wreck caused by a rear end collision, between two southbound passenger trains near Lawyers, Va., a station ten miles south of Lynchburg, on the Southern. Some of the dead, including Mr. Spencer, were burned almost beyond recognition. Eleven people were injured. The cause of the wreck, now under investigation, is not yet established, but the responsibility is supposed to rest on the operator of the block signal at Rangoon, has disappeared and is being searched for by the police.

ANOTHER MURDER

The Sinks is Again the Scene of a Shooting Scrape.

Word was received here last Tuesday morning of another murder in the "Sinks" of Pocahontas county, the victim being Isaac Arbogast, Jr., a native and a resident of that community. The murder was committed Monday evening and the murderer himself escaped death at the hands of an irate father by flight. Prosecuting Attorney Hill went to the scene of the murder Tuesday morning and an inquest was held by Squire A. M. Oliver. From the evidence we glean the following account of the murder.

Arbogast was married but had left his wife sometime before and on his leaving Staten Lambert, a young man of that community, had taken up his residence at the Arbogast home. Sometime before this the two men had made a barrel of matheglin, an intoxicating drink made by fermenting honey and water. Upon Arbogast's return to his home, after several months' absence, he took no notice of the attention paid to his wife by Lambert (for such a trivial matter is little thought of in the "Sinks" country) and the three lived together in comparative peace and happiness until the evening of the murder. On Monday evening Arbogast went home first in company with Kay Mullenax, a neighbor, and on their arrival they broke into Lambert's barrel of matheglin. Lambert came home shortly after and Arbogast said, "We have got into your matheglin, what do you think about it?" "I don't like it very d— well," replied Lambert. "Well," said Arbogast, "you can like it or let it alone just as you d— please." The quarrel kept up for some time and Arbogast was soon in a state of almost beastly intoxication. Lambert started to leave the house and in going out the door took his shot gun with him. Mullenax tried to prevent Arbogast from following him but he was powerless to do so. SPEAKEASIES RAIDED.

More Liquor Dealers in the Tails of the Law.

Another big raid was made on the illicit retailers at Danlevie Tuesday night of last week and as a result our erstwhile friend Johnny McGraw, "Smithy" and another who refuses to disclose his identity are languishing in the county jail. The raid was made by Lincoln Cochran, Pat and Ed Simmons and S. E. Ruckman. A large number of witnesses was found in the three places raided and a quantity of liquor and gambling paraphernalia was captured.

"Smithy" and the unknown retailer put up a game fight when confronted by the officers, and were aided by a number of their friends. It was only after Ruckman got out his gun and plowed a furrow through the forehead of one of the mob that the arrest could be made.

Church Waybright was arrested about the same time by Deputy Marshal Dan Cunningsham. He was sentenced to 30 days in the Pocahontas jail by Judge Dayton.

The other prisoners mentioned were brought to Marlinton at an examination Thanksgiving day before Squire Bird were placed under \$1,500 bond which was not forthcoming and they were placed in jail. Grant Haltermann, another person arrested on the same charge, was released on bail. It is the opinion of all who know anything at all about "Smithy" and the unknown man that they are a desperate pair and that they have a price set on their heads. In making the raid Cochran failed to turn over the warrants to Ruckman and on this technicality the warrant for them on the charge of assaulting an officer was dismissed.

Lambert then fled toward Durbin and was caught at Bartow the next morning by Sergeant White, of Durbin, who was on the hunt for him. He claimed that he was coming to Durbin to give himself up and put up the plea of self-defense. At the preliminary examination he was sent to jail to await action of the grand jury.

Both of the men are young, possibly not over 26 years of age, and Lambert has a pretty bad reputation.

Real Trees Hurt.

We do not know whether the men throughout the county made a close inspection of the young orchards to ascertain the extent of the damage done by the freeze, but in the neighborhood of Monterey the outlook is discouraging and indicates a serious loss to the county. The per cent of damage is great in other sections.

Dr. O. J. Campbell, who has a great pride in his young orchard near town, has gone to town to examine, not only his own but many others, and he estimates the destruction is very nearly complete. He thinks that at least 100 of his young trees are lost and estimates his loss at \$1000. R. B. Campbell, who has a large orchard in the hills east of town, has also lost most of his. On Straight Creek, C. W. Taylor had planted, perhaps, a thousand trees, and he, too, has lost a greater number of them.

The sap seems to have been caught, in its descent, about a foot from the ground, and, at that point many trees show the split and the body of the tree turning black. A loss such as this is far reaching and has a serious estimate. It is especially discouraging when we take into consideration the length of time required to grow an orchard. It is, however, but one course to pursue, and it is needless to say that many trees will be planted in Richland this season. If this fact assured, a few of our energetic young men should attempt to represent some of the

Mr. Miller will push to completion the preparation of an educational exhibit, while Prof. Lewis is preparing for an historical exhibit that will be extremely interesting and attractive as well as instructive.

Speaking of conditions at Jamestown Prof. Lewis says: "I spent two days on the exposition grounds and were not only surprised but astonished at the work done. It is safe to say the conditions there are now far in advance of what they were in St. Louis November preceding the opening of the Louisiana Purchase exposition.

The grounds are situated a few miles from the corner of the city of Norfolk and four miles from Old Point Comfort, this being directly across Hampton Roads, the best harbor in the world. The site assigned to West Virginia is one of the best in the entire position grounds. The waters of Willouby bay, a small inlet of Hampton Roads are not 100 feet distant from the West Virginia building, and spread out on every hand are the waters of Chesapeake bay, Hampton roads and the great estuary of the lower James, so that the shores beyond are seen only in dim outline.

"The building adjoining that of West Virginia is that of Georgia and then of Ohio, Missouri, Maryland, Virginia, Pennsylvania and other states in order along the shore."

"I succeeded," said Prof. Lewis when asked how the historical exhibit would be placed in the history building, "in securing space in a portion of the exhibition building, one of the best sites
