ACCEPTED IN SPEECH.

Maysville, Ky., June 18-The Ninth district Democratic congressional convention met this morning and nominated by acclamation James N. Kehoe for re-election. About half the thirteen counties were represented. Kehoe accepted in a graceful speech.

GREER ACQUITTED

One of the Alleged Murderers to go Free in Marshall.

He Was Charged with Killing John Thomas Two Years Ago.

The jury in the Greer murder case at Benton, Marshall county, this morning brought in a verdict acquitting James Greer, one of the three brothers charged with killing John Thomas, an old negro they met on the road near Little Cypress and comwhiskey and then beat to death, leaving him hanging across a fence to die.

There were three of the brothers and two of them came clear. The youngest one was acquitted soon after his arrest. The murder was unusually flendish, the murderers being toughs who were returning home drunk from ducah. James Greer was at the firs trial given a life sentence but the court of appeals reversed it.

MISS DODSON RESIGNS

POPULAR TEACHER TO QUIT THE SCHOOLS NOW.

Miss Mary F. Dodson, who for sev eral years past has been assistant prin cipal of the Paducah High school, and for many years a teacher in the Paducan public schools, has taught her last year, and will not be an applicant for position for the next term. Miss dson's resignation will be a serious blow to the schools, as she is one of the most efficient and popular teachers who ever taught here.

Washington, June 18-The Isthmian anal question was under consideraate. Speeches were delivered by Messrs. Perkins of California, Gallinger of New York, Stewart of Nevals and Morgan of Alabama. advocated the adoption of the Nicaragua route, except Gallinger, who made a forceful argument in support of the Panama route. He believed it was the more healthful. The argument of the senators in support of the Nicaraguan route was made especially on the ground of feasibility and busiess wisdom. Mr. Stewart and Mr. Morgan both contended that the health conditions in Nicaragua were superior to those of Pausma

The house spent the day considering bills reported from the judiciary committee. By far the most important measure was that to amend the existing bankruptcy law. The minority made a vigorous effort to repeal the present law in toto, but was overwhelmingly defeated-65 to 137. The most important amendment is one to define preference, to meet the supreme court decision in the case of Pire vs. Four additional grounds for refusing a discharge in bankruptcy also are add ed: First, obtaining property on credit on materially false statements; second, making a fraudulent transfer of property; third, having been granted or denied a discharge in bankruptcy within six years, and fourth, having refused to obey the order of the court or refusal to answer material questions session was held for the consideration

When the revolutionists were landed at Ciudad Bolivar, on June 7, Captain Meling was released and proceeded to the opposite shore, where he took cattle on board. He then proceeded down the river on his return

Passing San Felix, the Jotun was fired upon the two sternwheel steamers, carrying Venezuelan government troops. Captain Meling was instantly killed, and a passenger, Nunez, was wounded by the bullets.

Government boats then started for the Jotun, but putting on all steam, the vessel escaped, arriving on the morning of June 14, at Georgetown, where the news created some excite-





SPEND MONEY TO IMPROVE PARIS

Forty Million Dollars to Be Expended on Public Works.

The consul-general of the department of the Seine, in its last session, voted the issue of a loan of 8,000,000 pounds for the construction of public works in the department and in Paris. Some of these new undertakings are of considerable importance. Half a million is to be spent in enlarging the central halls, which, like the London Covent Garden, have long outgrown their limits and bulge out into the side streets, and 320,000 pounds on the Palais de Justice for its completion. A school of arts and crafts, which Paris has been crying for, is to be es-tablished at an expenditure of 3,000,-000 francs and the old prison of St. Lazare, with all its tragedy and pa-thos, is to be transferred elsewhere at a cost of about 1,500 pounds.

Other works include the continua-

tion of Boulevard Raspail, which, at the present moment, presents the phe-nomenon of a boulevard cut into sec-tions. The maples do not give the stranger any warning of the eccentric-ity, so he finds himself haited by a street which cuts the boulevard transversely and gives no avenue. He has to make a detour and regain the boul-evard at the back of the street. Another important work, upon w 24,000 pounds will be spent, is cerned with the transformation of the Boulevard des Batignolles. 
