





- Andrew, Jesse, Centre county, Pa. Son of Dr. John Andrew, surgeon's mate and afterwards surgeon. Commissioned in 1775 and served until the end of the war, he being present and on duty at the surrender of Cornwallis at Yorktown. No. 88.
- Andrew, Jesse C., Lafayette, Ind. Grandson of Dr. John Andrew, surgeon's mate and afterwards surgeon, as shown above. No. 89.
- Andrew, Thomas M., Lafayette, Ind. Grandson of Dr. John Andrew, surgeon's mate and afterwards surgeon, as shown above. No. 90.
- Anthony, A. Hunter, New Albany, Ind. Great-great-greatgrandson of Thomas Seabrook, first major First Regiment Monmouth county, New Jersey. Lieutenant-colonel of Colonel Read's Battalion, State Troops, November 27, 1776. No. 41.
- Anthony, Edwin Marsh, New Albany, Ind. Great-great-greatgrandson of Thomas Seabrook, first major First Regiment Monmouth county, New Jersey. Lieutenant-colonel of Colonel Read's Battalion, State Troops, November 27, 1776. No. 57.
- Atkins, Henry Cornelius, Atlanta, Idaho. Great-great-greadson of Abijah Brigham, second lieutenant in Captain Amasa Cranston's Company, October, November and December, 1779, Sudbury, Mass. No. 36.
- Atterbury, William Wallace, New Albany, Ind. Great-grandson of Simon Learned. Enlisted May 1, 1775. Ensign in Captain Angel's Company, Colonel David Brewer's Regi-



ment, adjutant and captain in Colonel William Shepard's Regiment, January 1, 1777, captain Second Company Fourth Massachusetts Regiment, January 17, 1782. No. 79.

- Bacon, Duncan T., Ogdensburg, N. Y. Great-grandson of Jacob Bacon, who, in the capacity of a private soldier, at the battle of Concord and Lexington, was wounded, and in the same battle, his uncle, Lieutenant John Bacon, was killed. At the battle of Bunker Hill, was a member of Captain Knowlton's Connecticut Company. Was on pension roll from July 20, 1832, until his death in 1844, for twelve months fifteen days' actual service in Connecticut troops. No. 39.
- Banta, William H., Preble county, Ohio. Great-grandson of Peter Banta, who, in the capacity of an enlisted soldier from Bergen county, New Jersey, is said to have served as a scout for five years; entire time of service being seven years. No. 51.
- Bates, Hervey, Jr., Indianapolis, Ind. Great-grandson of Daniel Bates, who joined the American Troops as a lad as private in Eastern Battalion, Morris county, New Jersey, Militia; afterwards as private in New Jersey State Troops, and finally under Captain Ward and Colonel Seely in the Continental Army, where he was serving when the war closed. He was then twenty-three years old. No. 93.
- Boggs, John McM., Pickaway county, Ohio. Great-grandson of Isaac Cook, commissioned as captain in the Connecticut Militia, May 1, 1775—Colonel David Wooster's Regiment. Discharged December 17, 1775; appointed major, January 10, 1780, in Colonel James Wadsworth's Regiment; promoted to lieutenant-colonel June 17, 1783. No. 114.
- Boggs, Lemuel S., Tippecanoe county, Ind. Great-greatgrandson of Isaac Cook, captain, major, and lieutenantcolonel in Connecticut Militia, Continental Troops, as shown above. No. 115.
- Boggs, Moses T., Tippecanoe county, Ind. Great-great-grandson of Isaac Cook, captain, major, and lieutenant-colonel Connecticut Militia, Continental Troops, as shown above. No. 116.

- Bond, Charles Ewing, Fort Wayne, Ind. Great-great-grandson of Benjamin Woodworth, a soldier in the Continental Army. No. 66.
- Bosworth, Rosecrans J., Winchester, Ind. Great-grandson of Richard Bosworth, corporal in Captain John Bradford's Company, Colonel Theophilus Cotton's Regiment, Massachusetts. Also as sergeant in Captain Jesse Sturtevant's Company, Colonel John Jacobs' Regiment, July 3 to October 29, 1780. No. 152.
- Bowers, Whitefield, near New Castle, Henry county, Ind. Great-great-grandson of John Proven, private in Massachusetts Troops of Captain John Ferguson's Company of Minutemen, who marched on Lexington alarm on April 19, 1775. No. 154.
- Brooks, William H., Bethel, Vt. Son of Reuben Brooks, who enlisted as a private in September, 1778, and served in the companies of Captains Bradley, Bunnel, Woodford, Tuttle, and Wadsworth, in all for two years and ten months. Enlisted at Bristol, Conn., and was granted a pension. Great-grandson of Edward Brooks, who appears with the rank of private in Captain Reuben Read's Company, Colonel Jonathan Warner's Regiment, which marched on the Lexington alarm, April 19, 1775, from Weston to Roxbury. Also as lieutenant in Captain James Convers's Company, Colonel Ebenezer Learned's Regiment at Roxbury Camp, January 18, 1776. No. 72.
- Brown, Guy W., Sheboygan, Wis. Great-great-grandson of Benjamin Lawrence, serving as sergeant in Captain Josiah Sartell's Company, which marched on the Lexington alarm from Groton to Cambridge. Also served as first lieutenant in Colonel Dike's Regiment, December 1, 1776, to March 1, 1777, and also as lieutenant in Colonel Jonathan Read's Regiment under General Gates, September 27, 1777, to November 9, 1777, and again as lieutenant in Colonel Wade's Regiment, March 14, 1778, until January 1, 1779. No. 138.

- Brown, Seneca Buel, Marlboro, Windham county, Vt. Grandson of Archelaus Dean, who enlisted as a private August 1, 1778, in Captain Barney's Company, and again, June, 1781, in Captain Riley's Company, both under Colonel Whitney. For his services he was granted a pension in 1833. No. 54.
- Brown, William John, Indianapolis, Ind. Great-grandson of George Brown, who served as a sergeant in Captain Jacob Valentine's Company, First Virginia State Regiment, commanded by Colonel George Gibson; enlisted March 1, 1777, and was in command of his troops at the surrender of Cornwallis, and from 1780 to 1790 continued in the service in the wars against the Indians, and for his services against the British received a land warrant which he located on Cabin creek, Mason county, Ky., about ten miles from Maysville. Great-great-grandson of John John, enlisted from Pennsylvania among the first troops, and in the winter of 1776-7 joined General Washington in Boston. He was with Washington at the surrender of Cornwallis, and was mustered out in 1782. No. 109.
- Bryant, Edwin D. Grandson of David Bryant, who enlisted as a private in the Sixth Company, First Regiment, commanded by Joseph Cilley. In 1780 he appears as lieutenant, and received a bounty of fifteen pounds from the town of Wear, N. H., for three years' services from January 1, 1777. No. 8.
- Bulson, Dr. Albert E., Jr., Chicago, Ill. Great-great-grandson of Abiel Abbot, who, in pursuance of appointments and orders from the New Hampshire Committee of Safety, mustered and acted as paymaster for seven companies of New Hampshire Troops. Also served in the capacity of major in Colonel Moses Nichols' Regiment of New Hampshire Militia, which marched by orders to re-inforce the garrison of Ticonderoga, June 29, 1777. No. 80.
- Butterfield, Algernon Sidney, Jr., Cincinnati, Ohio. Greatgrandson of Samuel Butterfield, sergeant in Captain Thatcher's Company, Colonel Gardner's Regiment; also second lieutenant in Captain Walton's Company, Colonel

Brooks's Regiment, for various periods between May 11 and November 16, 1776. No. 130.

- Cardwill, George B. Great-grandson of Isaac Train, a soldier under Captain Zebulon Sabin and Captain Parker, Colonel Seth Warner's Regiment; also later with Captain White, Colonel Sammon's Regiment. Was with Captain Parker at the Battle of Bennington, August 16, 1777, and was again in Colonel Rufus Putnam's and Colonel Rose's Regiments. He was a pensioner. Great-grandson of Joseph Sweezy, a private soldier in Captain Audrew White's Company of Colonel Wessenfel's Regiment of Levies, raised for the defense of New York in November, 1781. No. 25.
- Carnahan, Robert Hanna, Lafayette, Ind. Great-great-grandson of William Fairfield, private soldier, who enlisted July 17, 1775, and is shown on muster and pay-roll of Captain Benjamin Hoover's Company, stationed at Biddeford; discharged December 31, 1775. Again shown on muster and pay-roll of Captain Daniel Merrill's Company, Colonel Sainuel Brewer's Regiment, enlisted February 1, 1777; discharged March 17, 1777. Marched to Bennington. Appears again with rank of private of Captain Hitchcock's Company, Colonel Stroul's Regiment, Continental Army, February 1, 1777, to December 31, 1779. No. 91.
- Carpenter, Richard, Oberlin, Ohio. Great-great-grandson of Elisha Moore, who served as quartermaster in Colonel Enos's Regiment, Connecticut Troops, Continental Army. He was drafted and served in New York and Westchester in August and September, 1776, and was made quartermaster in 1777. No. 126.
- Carter, Cassius M., Livonia, Ind. Great-grandson of William Wright, who enlisted three times in the Revolutionary Army, with the following terms of service: 1780, three months, Captain James Robinson's Company, North Carolina Troops; 1781, three months, Captain John Raines's Company; 1781, three months, Captain William Gray, Colonel Thomas Dugan, North Carolina Troops. Was engaged at the battle of Island Ford. No. 100.



- Clark, Wellington A., Naples, N. Y. Son of Benjamin Clark, who served through the eight years of the Revolutionary War. He is first shown as private, Lieutenant Moses Adams's Company, Colonel John Smith's Regiment; marched on alarm, April 17, 1775, from Medway, Mass.  County Regiment, for service, Rhode Island. Enlisted March 3, 1781; discharged March 17, 1781. No. 56.
- Coffin, Charles E., Salem, Ind. Great-grandson of Matthew Coffin, who acted as a volunteer under General Greene in his Southern campaign, and was at the battle of Guilford Court-House, March 15, 1781. No. 50.
- Colfax, Schuyler, South Bend, Ind. Great-grandson of William Colfax, who served as captain of General George Washington's Life Guards. No. 15.
- Cooper, William H. M., Bartholomew county, Ind. Greatgrandson of Adam Cooper, who served as a private soldier, but services and dates unknown. No. 47.
- Culbertson, Charles W., Madison, Ind. Great-grandson of Samuel Culbertson, who, on December 8, 1776, was a captain in Colonel Joseph Armstrong's Battalion (Fifth) of Cumberland county, Pennsylvania, Associates. July 31, 1777, was commissioned colonel in Sixth Battalion; May 10, 1780, was lieutenant-colonel of the Fourth Battalion. Great-great-grandson of John McClay, who was a member of the first conference at Carpenter's Hall, at Philadelphia, in June, 1776. No. 73.
- Curtis, John Jay. Great-grandson of Samuel Curtis, a private in the Continental Line. Great-grandson of —— Jeffries, who served as secretary or aide-de-camp to General Schuyler previous to his being suspended by General Gates. No. 35.
- Daniels, William D., Marietta, Ohio. Great-grandson of Ephraim Warren, who was plowing in the field when the Lexington alarm was given, enlisting at once in Haskell's Company, Colonel James Prescott's Regiment, which

marched on April 19, 1775, from Shirley, Mass. He reported for duty at every call, serving from then until his death, April 7, 1783. No. 147.

Denny, James T., Putnam county, Ind. Grandson of William Denny, who was a lieutenant in the Continental Army and was with General Morgan during the campaign in which the Battle of the Cow Pens was fought, and participated in that engagement. No. 45.

- DePauw, Newland T. Great-grandson of Charles DePauw, who was wounded at the siege of Yorktown, from which wound he eventually died. Great-grandson of Benjamin Newland, a Quaker, who was drafted at the age of sixteen into the regular army in 1779, serving through the remainder of the war, and was one of the soldiers that guarded Cornwallis's Army at Hagerstown, Md. No. 12.
- Doyal, John L., Frankfort, Ind. Great-grandson of John Doyle, who was a private soldier under Colonel George Rogers Clark in his Western campaign, as shown below. No. 143.
- Doyal, Samuel H., Lewis county, Ky. Grandson of John Doyle, who was a private soldier under Colonel George Rogers Clark in his Western campaign, and came down the Ohio river with Clark and through the Illinois campaign to Kaskaskia. He was also with Clark at the capture of Fort Vincennes. No. 83.
- Dunning, John, Pownal, Bennington county, Vt. Son of Josiah Dunning, who, some time in April, 1775, joined a volunteer company at Pownal, Vt., where he then resided, and joined the forces under Colonel Benedict Arnold against Ticonderoga and Crown Point, after capture of which he remained in service until following September, when his company was dismissed. During 1776, he served for about two months as one of the guards to the military stores at Sunderland, Vt. In July, 1777, he became orderly sergeant of company commanded by Captain Eli Nobles, and participated in the campaign which ended in the defeat of the British at the battle of Bennington, and

was also present at the surrender of General Burgoyne at Saratoga. He was granted a pension. No. 42.

- Early, Jacob D., Terre Haute, Ind. Great-great-grandson of Dr. Charles Alexander Warfield, who was a major of the Elk Ridge Battalion of Maryland. Also appointed and acted as a member of various patriotic committees in and around Baltimore. No. 104.
- Eastham, Stephen S., Vincennes, Ind. Great-great-grandson of Edmund Burnet, who was a minute-man and a private in the New Jersey militia, serving five months, from June, 1776, under Colonel Martin, and eight months, from December, 1776, under Colonel Ford. Was engaged in the battles of Long Island and White Plains. Was granted a pension, under application dated May 23, 1833. No. 103.
- Eddy, Horace J., Delphi, Ind. Great-grandson of Eliakim Eddy, private in Captain Levi Brown's Company, Colonel Asa Barns' (Berkshire county) Regiment. Enlisted October 30, 1781; discharged November 7, 1781. Marched on alarm to join General Stark at Saratoga. No. 105.
- Elliott, Ashley J., Evansville, Ind. Great-great-grandson of Solomon Dwinnell, who enlisted December 10, 1775, at Rosebury, Mass., as a private, being discharged and reenlisting several times, and serving in many battles until the end of the war. No. 44.
- English, William E., Indianapolis. Great-grandson of Phillip Eastin, lieutenant in Fourth Virginia Regiment during the entire war. Great-great-grandson of Charles Smith, an officer under Washington, as shown below. No. 18.
- English, William Hayden, Lexington, Scott county, Ind. Grandson of Phillip Eastin, who was a lieutenant in the Fourth Virginia Regiment, Continental Army. Greatgrandson of Charles Smith, who was an officer under Washington in Braddock's War, and lost his left hand at the battle of Big Meadow or Braddock's defeat. No. 1.
- Fairbank, Clark, Antrim, N. H. Grandson of Zaccheus Fairbank, who served as minute-man under Captain Gleason at Concord and Cambridge in response to the Lexington alarm. Also as private in Captain Gardner's Company,

raised at Sherburne, Mass., under call of September 10, 1776, and was in service on the North river until November 19, 1776. No. 65.

- Ferris, Edgar S., New Castle, Ind. Great-grandson of Samuel Ferris, sergeant in Connecticut Troops, as shown below. No. 134.
- Ferris, Samuel, near Brookville, Franklin county, Ind. Grandson of Samuel Ferris, sergeant in Captain George Peck's Company, Ninth Regiment of Connecticut Militia, Lieutenant-Colonel John Mead. Also serving with Connecticut Troops in New York in 1776. No. 133.
- Fisher, David C., Little Falls, N. Y. Great-grandson of David Chambers, colonel of New Jersey Militia, as shown below. No. 64.
- Fisher, Robertson J., Little Falls, N. Y. Great-grandson of David Chambers, who served as colonel of the Third Regiment, Hunterton county, New Jersey, Militia, June 19, 1776. Also as colonel of a battalion of the New Jersey State Troops, November 27, 1776. Was commissioned colonel of the Second Regiment, Hunterton county, New Jersey, Militia, September 9, 1777, and resigned May 28, 1779. No. 61.
- Fitch, Charles B., York township, Medina county, Ohio. Great-grandson of Thomas Brintnall, who was commissioned second-lieutenant in Second Company of the Middlesex county, Massachusetts, Regiment, January 7, 1779. Also as captain of a company in Colonel Cyprian Howe's Regiment for service at Rhode Island, August 4, 1780, to November, 1780. Enlisted for three months to reinforce Continental Army. No. 60.
- Fitch, Otis B., York township, Medina county, Ohio. Greatgrandson of Thomas Brintnall, second-lieutenant in 1779, and captain in 1780, as shown above. No. 62.
- Fowler, George S., Bristol, N. H. Great-grandson of Jonathan Leavitt, who enlisted August 1, 1775, in Captain Gilman's Company, Colonel Enoch Poor's Regiment, New Hampshire Troops, and is shown as serving in various regiments in the capacity of private, sergeant, ensign, and lieutenant,

and was appointed captain June 23, 1778, in Colonel H. Mooney's Regiment for the defense of Rhode Island. No. 59.

- Fowler, Inman H., Lewisburg, Preble county, Ohio. Greatgrandson of Jacob Kesler, who enlisted in York county, Pennsylvania, serving four separate terms of two to three months each in various companies under Colonels Swope and Albright, Pennsylvania Troops. Was granted a pension under application, September 21, 1832, when he was residing at Harrison, Ohio. No. 123.
- Goldthwaite, Edgar L., Marion, Ind. Great-grandson of Thomas Goldthwaite, who served for thirty-six months and ten days in the Seventh Massachusetts Regiment, under Captain Luke Day, Lieutenant-Colonel Brooke. Also as lieutenant in Captain Day's Company, Colonel Ichabod Alden's Regiment. Term of service, January 11th, 1777, to August, 1780. No. 85.
- Granger, Horace G., Mechanicsburg, Ohio. Great-grandson of John Foster, who served as a private in Captain Joseph Briggs' Company, Vermont Militia, from the 1st day of October, 1778, to 24th day of November, 1778. Also sergeant of Captain Benjamin Cox's Company for scouting in Barnard in August, 1780. No. 81.
- Graves, Charles E., Sunderland, Mass. Great-grandson of Eben Smith, who appears with rank of private on Lexington alarm roll of Captain Ebenezer Battle's Company, which marched on the above alarm, April 17, 1775, from Dedham, Mass. No. 78.
- Griffin, George G., Madison, Ind. Great-great-grandson of Robert Beall, first lieutenant in the Eighth Regiment of regular forces under command of Colonel Peter Muhlenberg. His commission, being signed by the Committee of Safety of the Colony of Virginia, is now in possession of the family. No. 96.
- Grose, William. Grandson of Jacob Grose, who was killed while acting as a teamster in the Revolutionary service. Grandson of John Hubbell, a private and probably a sergeant in the Revolutionary Army. No. 3.



- Hale, William B., Richmond, Ind. Great-great-grandson of Euoch Hale, who is said to have served as a soldier in the American Army, there being no proof outside of the family tradition. No. 22.
- Hatch, Aretas Wallace, La Salle, Ill. Great-great-grandson of John McCrea, who was appointed colonel of the Thirteenth Regiment New York Militia, October 20, 1775, and was reappointed colonel of the same regiment on June 22, 1778, resigned, March 24, 1781. No. 84.
- Hatch, Jethro A., Chenango county, N. Y. Grandson of Timothy Hatch. Enlisted as private in Fourth Connecticut Troops, April, 1777. Discharged January, 1778. He also appears as drummer in Captain Prior's Company. He is also shown as a private on the list of Connecticut Revolutionary Pensioners, allowed for six months' and ten days' actual service. Great-great-grandson of Jethro Hatch, who appears as major of Thirteenth Connecticut Regiment, October, 1776, and also as major of Colonel Moseley's Regiment. No. 144.
- Hatcher, Robert Stockwell, Lafayette, Ind. Great-grandson of Anthony Debrill, Jr. A certificate, issued by the Bureau of Pensions, states that Charles Debrill went to Yorktown in the fall of 1781 to relieve his brother, who was in feeble health, but learning that the enemy must shortly surrender, both brothers remained. Anthony Debrill, Jr., was the only brother of Charles, and it is certified that he was too much debilitated to march with the prisoners to Winchester, Virginia. Great-great-grandson of Jacob Drennan, a soldier under General George Rogers Clark, in the expedition against the British posts in the Northwest. No. 98.
- Hawkins, Nathan B., Portland, Ind. Great-grandson of Samuel Hawkins, who, at the age of fifteen years, left his home in the Shenandoah Valley, Virginia, and joined the Pennsylvania Volunteers, at Philadelphia, and went to the camp at Valley Forge and served from Valley Forge to Yorktown as a private soldier. Great-grandson of Nathan

Sellars, sergeant in Pennsylvania Volunteers, serving from 1775 to 1782. No. 38.

- Hazelett, Richard M., Mouroe county, Ind. Grandson of Mordecai Miller, private soldier in the expedition under Colonel George Rogers Clark against Fort Vincennes, and has a very interesting history, claiming that he had been in over one hundred skirmishes and battles with the Indians, Torics, etc., and came off without a scratch. No. 48.
- Heston, William D., Philadelphia, Pa. Great-grandson of Edward Heston, who served as lieutenant-colonel under General Potter, of the Pennsylvania Militia, from November 14, 1777, to January 3, 1778. He was taken prisoner at a skirmish at Blockley, Philadelphia county, and held about two months. No. 101.
- Holliday, Jacquelin S., Indianapolis. Great-great-great-grandson of William Aylett, colonel and assistant commissarygeneral of Virginia in the Revolutionary War. He furnished supplies to the army—blankets, clothing, etc., from his own means, giving his individual bonds in payment, the settlement of which, after his death, exhausted his estate. He died at Yorktown at his post of duty in 1781. Great-great-great-grandson of Patrick Henry, whose record is known to all readers of American history. No. 28.
- Holliday, William J., Winchester, Va. Great-grandson of Philip Bush, who was quartermaster-general of the United States from October 4, 1780, to December 23, 1780, but how much longer or what other office held is not shown. During the above period he was stationed at the Camp of the Hessians, prisoners of war, at Winchester, Va. No. 55.
- Huston, Cephas B., Mercersburg, Pa. Grandson of James Huston, captain in the Continental Army, who was with General Washington when he crossed the Delaware river at Trenton, N. J. Great-grandson of George Ross, who signed the Declaration of Independence from Delaware. No. 27.
- Huston, Samuel M., Butler county, Ohio. Great-grandson of John Huston, who was a soldier in the Revolutionary War, and was said to have been a captain. Great-grand-

son of Asa Harvey, who was an officer in the army, and, when the war closed, held the rank of major. Greatgrandson of Richard Mack, a private who lived 'long enough to enjoy the benefits of a pension given the surviving veterans of the Revolution. No. 49.

- Jewett, Henry E., Lexington, Ind. Great-grandson of Joseph Jewett, appointed captain in Colonel Huntington's Regiment, Seventeenth Continental, for year 1776. Was mortally wounded and taken prisoner at the Battle of Long Island, August 27, 1776. Died August 29, 1776. No. 97.
- Judah, Charles B., Vincennes, Ind. Great-great-grandson of Edmund Burnet, who served as a minute-man and private in the New Jersey Militia, under various enlistments, from June, 1776. Was engaged in the battles of Long Island and White Plains. Applied for a pension May 23, 1833. See S. S. Eastham, above. No. 99.
- June, George W., Newburgh, N. Y. Great-grandson of Captain Jesse Penny, who, while acting in the capacity of a pilot, refused to pilot an English man-of-war through Hell Gate on East river. On refusal, he was consigned to the prison ship Jersey, from which he escaped by swimming to the New Jersey shore, finally reaching Newburgh, where he died shortly after from exposure incident thereto. No. 40.
- Kenyon, Clarence A., Yorkville, Mich. Great-great-grandson of Ludovick Kenyon, who was a soldier in Colonel John Tophan's Regiment in 1776. Great-great-grandson of William Allen, who served as captain in Second Rhode Island Regiment, commanded by Colonel Israel Angell, in 1779, his commission being dated February 11, 1777. He was afterwards general and a distinguished officer in the Revolutionary War, and his name is historically well known. No. 110.
- Kollock, Frederick N., Burlington, N. J. Grandson of Shepard Kollock, lieutenant and brevet captain Second Regiment Artillery, Continental Line, 1776-8, and editor of the New Jersey Journal, an organ established at the seat

of war, Chatham, N. J., in 1789, at the request of Washington. A reward was offered for his capture or death. No. 23.

- Landers, Franklin, Landersdale, Morgan county, Ind. Grandson of Nimrod H. Stone, who enlisted at Fauquier county, Virginia, on April 28, 1781, as a private in Captain William Triplet's Company, in Colonel Francis Triplet's Regiment. Was engaged in the siege of Yorktown. On September 16, 1833, applied for, received, and drew a pension until the time of his death. No. 119.
- Landon, Lucius H., Berrien Springs, Mich. Great-grandson of Rufus Landon, who enlisted February, 1776, as drummer in a company of artillery, Captain John Bigelow. His term of service was for one year, and he was discharged at Mount Independence, opposite Ticonderoga. Re-enlisted later under Captain Pelleton, and served as hospital nurse and guard in various places. Applied for pension May, 1818, which was granted. No. 146.
- Levering, Mortimer, Ardmore, Pa. Great-grandson of John Levering. The original certificate is in existence showing that on the 20th of May, 1778, John Levering, of Roxbury township, Pennsylvania, took the oath of allegiance as ensign of the Second Battalion, Philadelphia county. In May, 1780, was made captain of the Sixth Company of the Seventh Battalion, Lieutenant-Colonel Mathew Holgate. He was in the battles of Trenton, Princeton, and other engagements. No. 70.
- Lincoln, Theodore, Dennysville, Maine. Great-great-grandson of Benjamin Lincoln, commissioned February 8, 1776, as brigadier-general of Suffolk county, Massachusetts, Militia. Appears with rank of major-general on Continental Army pay accounts from February 19, 1777, to December 31, 1780, and was one of Washington's intimate official associates. No. 132.
- McConnell, Dr. George W. Grandson of James McConnell, who enlisted and was commissioned as captain August 16, 1776; was placed in charge at King's Bridge and later wintered at Valley Forge with General Washington.

Grandson of Joseph Lucky, captain in Chester county, Pennsylvania, Militia. Was taken prisoner while at home on a furlough. No. 13.

- McCulloch, Charles, Fort Wayne, Ind. Great-grandson of Nathaniel Platt, who raised the first company of volunteers on Long Island, and received his commission as captain from General Nicholas Woodhull, under whose command he served on Long Island and in Connecticut, and during the later part of the war as aid to General Washington. Great-grandson of Ebenezer Man, who enlisted as surgeon from Kent, Conn. He was brigade surgeon under Washington through the war and participated in the battle at Yorktown. No. 68.
- McCulloch, John Ross, Fort Wayne, Ind. Great-great-grandson of Nathaniel Platt and Ebenezer Man, whose records are shown above. No. 69.
- McDowell, Cincinnatus H., Nicholas county, Ky. Greatgrandson of Ephraim McDowell, who served as a private in Captain Jacob Teneyck's Company, Colonel Frederick Frelinghuysen's First Battalion, Somerset county, New Jersey, Militia. Great-great-grandson of Colonel Willett, who was on General Lafayette's staff. No. 5.
- McLain, Moses G., Marion county, Ind. Great-grandson of James Brenton, who was appointed major of militia in Monongahela county, Virginia, September 14, 1779, by Patrick Henry, Governor of Virginia. No. 24.
- Maitlen, Carleton W., Muncie. Great-great-grandson of Joshua Higman, water-carrier March 6 to October 1, 1778.
 Private in Jacquett's Company, Colonel David Hall's Delaware Regiment. No. 149.
- Manson, John M., Crawfordsville, Ind. Great-grandson of David Manson, whose record is shown below. No. 102.
- Manson, Mahlon D., Piqua, Ohio. Grandson of David Manson, private in the body guard of General Washington; also serving under various enlistments from July, 1776, to January, 1778, from York county, Pennsylvania. He was granted a pension for his services. Great-grandson of

George Cornwall, who was also a soldier from Virginia. No. 58.

- Manson, Mahlon F., Crawfordsville, Ind. Great-grandson of David Manson, whose record is shown above. No. 106.
- Manson, William N., Crawfordsville, Ind. Great-grandson of David Manson, record shown above. No. 107.
- Martindale, Charles, New Castle, Ind. Great-grandson of Samuel Boyd. Enlisted 1780 for twelve months as private in Captain Thomas's Company, Colonel Robuck's South Carolina Regiment. Enlisted 1781 for twelve months as private in Captain Earle's Company, Colonel Hazan's South Carolina Regiment, and in 1782 served under Captain Duval, Colonel Pickens's South Carolina Regiment. Lost left eye in battle of Bush river. No. 118.
- Mattison, Hamilton A., South Berlin, Rensselaer county, N. Y. Grandson of Allen Mattison. Enlisted September, 1776; served three months as private, Captain Whitman's Company, Colonel Cook's Rhode Island Regiment. Served four months in 1777 as private in Captain Roy's Company; two months in 1778 as ensign in Captain Bennett's Company, and two months in 1779 as sergeant in same company. Applied for a pension August 9, 1832. No. 10.
- Mauzy, James H., New Salem, Rush county, Ind. Greatgrandson of William Mauzy, who served as private for a term of three months, in 1779, in Stafford county, Virginia, Militia, Captain Rolly Brown's Company, Colonel Girard's Regiment. Applied for pension September, 1832. No. 113.
- Meredith, Samuel Caldwell, Green county, Pa. Son of John Wheeler Meredith, who, about the time of the outbreak of hostilities, was in a merchant vessel en route for Delaware, which was attacked by a British man-of-war; the vessel being captured, he and the crew were made prisoners. In a few days a French vessel recaptured him, from which he found his way to the Colonies. After recovering from wounds received in the engagement at sea, he enlisted as a private in the Continental Army, participating in the battle of Saratoga; also in the battle of the Cow Pens, January 17, 1781, where he was

again wounded, for which injuries he received a pension. No. 43.

- Merrill, Samuel, Indianapolis. Great-grandson of Samuel Merrill; grandson of Jesse Merrill, whose records are shown below; grandson of Robert Anderson, who is said to have taken an active part with the Colonial Troops and became captain. No. 7.
- Moores, Charles Washington, Indianapolis. Great-greatgrandson of Samuel Merrill, who was captain of the Second Company at Haverhill, Mass., of the Fourth Essex County Regiment, Samuel Johnson, colonel, and present at Burgoyne's surrender; great-grandson of Jesse Merrill, who served in his father's company and was with him at Burgoyne's surrender; great-grandson of Peter Dumont, who was a Revolutionary soldier; great-grandson of Robert Anderson, captain of a New York company. No. 2.
- Moores, Merrill, Indianapolis. Great-great-grandson of Samuel Merrill; great-grandson of Jesse Merrill; great-grandson of Peter Dumont; great-grandson of Robert Anderson, records shown above. No. 20.
- Morey, William H., Lowell, Lake county, Ind. Great-grandson of William Peach, a private soldier of Marblehead, Mass. A pensioner. No. 155.
- Mossman, Bertrand Paul, Coesse, Whitley county, Ind. Greatgreat-grandson of Heaberd Smallwood, who served as captain of Grayson's Additional Virginia Continental Regiment from March 4, 1777, resigning October 6, 1778. No. 140.
- Murphey, Charles Powel, New Castle, Ind. Great-grandson of William Carpenter 2d, who served as a private in Colonel Benjamin Holmes's Second Battalion, Salem county, New Jersey, Militia. No. 153.
- New, Harry S., Indianapolis, Ind. Great-grandson of Jethro New, a major in the Continental Army, taking part in many of the battles. He was one of the guards at the execution of Major Andre. For services he was given a grant of land in Southern Indiana. No. 33.

- Newland, Elijah. Son of Benjamin Newland, who joined the Revolutionary Army in 1779, when he was sixteen years old, serving to the close of the war as a private, and was one of the guards of Cornwallis's Troops at Hagerstown. No. 11.
- Newton, Charles H., Sacramento county, Cal. Great-grandson of John Newton, who enlisted July 20, 1776, in Captain Charles Smith's Company, and was discharged January 14, 1777. Great-grandson of Jonathan Clark, who enlisted July, 1779, under Captain Daniel Allen, Colonel Levi Wells's Connecticut Troops, serving eight months. Enlisted again in 1781 and in 1782. Application for pension filed July 26, 1832. No. 122.
- Newton, Frederick A., Syracuse, N. Y. Grandson of John Newton, who served as a private in Colonel Bradley's Battalion of Connecticut Troops, and was one of the soldiers engaged in the erection of Fort Trumbull. No. 52.
- Niblack, William E., Dubois county, Ind. Great-grandson of Thomas Hargrave, a private soldier in a company of Virginia Troops. After serving considerable time, he became sick from disease contracted in the service, from which he died after reaching his home. No. 31.
- Nicholson, Meredith. Great-grandson of John Wheeler Meredith, who enlisted in March, 1777, for three years, participating in the battles of Saratoga and the Cow Pens, as shown under name of Samuel C. Meredith, above. No. 26.
- Noble, Robert W. P., near Centreville, Wayne county, Ind. Great-great-grandson of Samuel Boyd, who lost an eye and nearly lost his life by a ball from a Tory gun. His father, James Boyd, died in a Tory prison during the Revolutionary War. See C. Martindale, above. No. 46.
- O'Brien, James. Great-grandson of Enoch O'Brien, who assisted in establishing American Independence. No. 6.
- Palmer, Asa G., Watseka, Ill. Great-great-grandson of Jarvis Mudge, who was captain of minute-men, serving three campaigns of several months each. Was appointed first lieutenant of Fifth Company of Colonel Vanschaack's Al-

bany Regiment; Captain White's Company, July 11, 1775. No. 120.

- Payne, Earl H., Rushville, Ind. Great-great-grandson of William Mauzy, a soldier in Captain Rolly Brown's Company, Colonel Guard's Regiment, of Stafford county, Virginia, Militia, serving three months in 1779. Also in September, 1780, under the same officer, being stationed at Stafford Court-House, until discharged. Made application for pension, September 30, 1832. No. 131.
- Poindexter, Charles E., Jeffersonville, Ind. Great-grandson of Barzillai Willey, who enlisted as a private soldier at the age of fourteen, at Hartland, Hartford county, Conn., and again in 1783. He was present at Burgoyne's surrender. He was a pensioner at the time of his death. No. 148.
- Prentiss, Nelson, Genesee county, N. Y. Son of Nathaniel Prentiss, who, when about thirteen years of age, ran away from home and went to the army, where he obtained a position to some officer, supposed to be General Putnam. Being large for his age, he was soon after permitted to enter the service, in 1778 or 1779. He was at West Point and saw Major Andre executed. After his enlistment expired, he shipped as a seaman on board a privateer chartered by the governor of Connecticut. The vessel was captured and taken to New York, where the crew were imprisoned in the prison ship Jersey. After suffering untold misery, they were taken to the Island of Jamaica, where they were kept until the close of the war, when they were told to shift for themselves. He was granted a pension from March 4, 1831, dying January 23, 1839. No. 4.
- Pyke, Frank H., Peru, Ind. Great-great-grandson of Oliver Babcock, lieutenant Third Company, Sixth Regiment, Colonel Parson's Continental Line. Also served in Knowlton's Rangers; commissioned ensign May 1, 1775; promoted to lieutenant July 1, 1775; discharged December 10, 1775; re-entered service 1776 as first lieutenant; taken prisoner November 16, 1776, at Ft. Washington; exchanged about January 1, 1777. No. 137.

- Ratliff, John A., Henry county, Ind. Great-great-grandson of John Provence (or Proven), private in Colonel Danielson's Regiment, Massachusetts Troops, as shown below. [See Adolph Rogers.] No. 135.
- Ratliff, Levi S., Henry county, Ind. Great-great-grandson of John Provence, private in Colonel Danielson's Regiment, Massachusetts Troops, as shown below. [See Adolph Rogers.] No. 139.
- Roache, Addison L., Rutherford county, Tenn. Grandson of Stephen Roache, private soldier in the service in North Carolina. Grandson of Robert McCorkle, soldier North Carolina Troops. No. 16.
- Robinson, Henry Harrison. Great-grandson of Obadiah Meeker, captain of the Light Horse Cavalry of Elizabeth, N. J., which formed part of the escort of Washington to Elizabethtown Point, whence they embarked to New York. No. 14.
- Rogers, Adolph, Henry county, Ind. Great-grandson of John Provence, [or Proven] who appears as private on Lexington Alarm Roll of Captain John Furguson's Company, Colonel Timothy Danielson's Regiment, which marched April 20, 1775. He is also shown as having performed various other services with Massachusetts Troops, and was killed in battle during the war. No. 111.
- Scheuch Frederick C., Lafayette, Ind. Great-grandson of Jacob Bauer, first lieutenant in German Regiment, 8th of July, 1776. Captain of Ottendorff's Battalion, April 9, 1777. Resigned September 22, 1777. No. 145.
- Scoville, Charles E., Watertown, N. Y. Great-grandson of Reuben Ballou, who was commissioned captain on the recommendation of the General Assembly held for the Colony of Rhode Island at Newport on third Monday in August, 1776. Also captain of the Second Company of Militia from the town of Cumberland, R. I. He entered the service soon after the battle of Bunker Hill. Later he was major and served till the end of the war. No. 121.
- Sims, Clifford S., Jr., Desha county, Arkansas. Great-greatgrandson of John Ross, captain of Third Regiment New

Jersey Continental Line, March 13, 1776. Major Second Regiment New Jersey Continental Line, April 7, 1779. Brigade inspector October, 1779, to November, 1780. Retired January 1, 1781. Great-great-great-grandson of Alexander Ross, surgeon Continental Hospital Department. Great-great-grandson of Elijah Clark, lieutenantcolonel Second Battalion Gloucester County, New Jersey Militia. Resigned November 6, 1777. No. 76.

- Smythe, Elmer A., Greencastle, Ind. Great-great-grandson of Julius Glazebrook, private in Virginia troops as shown below. No. 150.
- Smythe, William H., Putnam county, Ind. Great-grandson of Julius Glazebrook, private in Captain Thomas Williams's Company, Virginia Troops, for five months from June 10, 1780. Served three months from 1781 in Virginia in Captain Andrew Wallace's Company. No. 136.
- Snyder, David E., Philadelphia, Pa. Grandson of Philip Snyder, who was appointed August 21, 1777, as ensign of a company in Sixth Pennsylvania Regiment. The original commission is signed by John Hancock, president, and Charles Thompson, secretary of the National Congress. Great-grandson of Andrew Donaldson, who performed military services in establishing independence. No. 17.
- Somes, Henry Vanderburgh. Grandson of Henry Vanderburgh, who, at the age of 16, was appointed a lieutenant in the Fifth New York Regiment, dating November 21, 1776. His commission was signed by John Jay, then president of the Continental Congress. He was reappointed by John Hancock, president of the Congress, June 20, 1779; and September 30, 1780, was appointed captain of Second Regiment Continental Troops raised in New York, serving until the close of the war in 1783. No. 9.
- Somes, James E. Grandson of Henry Vanderburgh, second lieutenant and captain of New York Troops as shown above. No. 19.
- Stein, Theodore. Great-grandson of Carl August Ebert, private soldier, whose record is not detailed. Tradition says

he was a Hessian soldier who joined the American troops. No. 21.

- Stimson, Charles O. Washington Court-House, Ohio. Greatgreat-grandson of Asa Lawrence, who marched as captain of his company on the Lexington alarm, April 19, 1775, from Groton to Cambridge. No. 125.
- Stitt, Thomas Lutz, Wabash, Indiana. Great-great-grandson of Frederick Lutz 1st, who, in the capacity of ensign in Yost Dreisdach's Battalion of Northampton County Associators, took the field in August, 1776, and in the latter part of that month took part in the battle of Long Island under General Mifflin. He was with Washington's Army in its retreat to White Plains and in its flight through New Jetsey. No. 124.
- St. John, Robert T., Covington, Miss. Grandson of John St. John, who served three months as corporal in Jabez Gregory's Company, Connecticut Militia, in 1776; as second lieutenant in Captain Northup's Company, Colonel Silliman's Regiment, in 1776; as first lieutenant in Colonel Philip Bradley's Regiment in 1777; was made captain May 25, 1777; served in several engagements, including the storming of Stony Point; resigned May 1, 1781. He was allowed a pension for services as captain. No. 142.
- Strickland, Charles B., New Castle, Ind. Great-great-grandson of Moses Craft, private in Lieutenant John Mareau's Company, which marched on the Lexington alarm, April 19, 1775. Corporal in Captain Phineas Cook's Company, Lieutenant-Colonel William Bond's Regiment, in 1775. Private in Captain Fuller's Company in 1776; private in Captain Kirkland's Company in 1777. No. 129.
- Sulgrove, James, Indianapolis, Ind. Great-grandson of Thomas Jameson, who first served as a militiaman six months prior to enlisting in Company H, Morgan's Brigade of Virginia, from Henry county or court-house. He was a pensioner at the time of his death, in 1830. No. 30.
 Swann, Clarence S., Fort Wayne, Ind. Great-grandson of Joseph Barnett, second lieutenant Colonel Timothy

Green's Battalion of Lancaster County Associators, in service in the Jerseys in 1776. No. 77.

- Taffe, Hannibal, Marion county, Ind. Great-grandson of William Herrot, captain under General George Rogers Clark, June 24, 1779. No. 87.
- Taylor, Harold, Indianapolis, Ind. Great-grandson of Robert Taylor; enrolled October, 1779, from Boonsboro, Va., under Captain John Constant. In 1780 was called to go in pursuit of Indians under Captain John Holden and Colonel Logan, and joined forces of General George Rogers Clark. In February, 1781, was enrolled and drafted for three months' service as orderly sergeant under Captain George Bell. Participated in the siege of Yorktown. Was present at the surrender of Lord Cornwallis, and was granted a pension. No. 117.
- Thompson, John W., Lafayette, Ind. Great-grandson of Robert Thompson, private in New Jersey Continental Line, as shown below. No. 86.
- Thompson, Lewis R., Lafayette, Ind. Great-grandson of Robert Thompson, private in New Jersey Continental Line, as shown below. No. 75.
- Thompson, Richard G., Jr., Lyons, Iowa. Great-grandson of Peleg Sisson, who enlisted in the spring of 1776 under Captain John Salisbury, Colonel Van Ness, New York Troops. Also served as sergeant for nine months under Captain Cornelius Hogdorn. Was in several engagements with the British Army under Burgoyne. He was granted a pension in 1832. No. 67.
- Thompson, Robert J., New York City, N. Y. Great-grandson of Robert Thompson; served as private in the Seventh Battalion, Second Establishment New Jersey Continental Line. Also as private in Captain Cyrus DeHart's Company, Second Regiment New Jersey Continental Line. No. 74.
- Thompson, William C., Greenfield, Ohio. Great-grandson of Thomas Thompson, who volunteered from New Jersey at the beginning of the war, and served as quartermaster in the army of General Washington, under command of

General Reed. Great-grandson of John Corman, a private soldier from New Jersey in Washington's Army. Greatgrandson of Thomas Craven, private soldier from Pennsylvania, and was in camp at Valley Forge with Washington's Army. No. 128.

- Todd, Levi L., Fayette county, Ky. Grandson of Robert Todd, captain under General George Rogers Clark, in campaigns against the British posts Northwest of the Ohio river. Grandson of Captain Nathaniel Ashby, who served in the Continental Army from Virginia. No. 108.
- Townley, George E., Cincinnati, Ohio. Grandson of Edward Townley, private in Captain Christopher Marsh's Company, Light Horse, Essex county, New Jersey, Militia. No. 127.
- Treat, Atwater J., Orange, Conn. Great-grandson of Samuel Treat, captain and major of Second Company, Second Regiment Connecticut Troops, 1775 to 1778. No. 92.
- Tuttle, Herman C., Sullivan, N. Y. Great-grandson of Charles Tuttle, who enlisted in Wallingford, Conn. Was at the Battle of Bunker Hill, and served for five years in the Revolutionary Army. Was with General Gates at the surrender of Burgoyne. Great-great-grandson of Jehiel Tuttle, lieutenant in the French War, and in the expedition against Ticonderoga and Crown Point. Was wounded and died in camp in 1759. Great-great-greatgrandson of Daniel Tuttle, captain of militia in Wallingford, Conn., in 1738. No. 94.
- Tuttle, Richard B., Sullivan, N. Y. Great-grandson of Charles Tuttle, private in Connecticut Troops, as shown above; also of Jehiel Tuttle and Daniel Tuttle, as shown above. No. 95.
- Van Buren, William Allen, Watertown, N. Y. Great-grandson of Jarvis Mudge, who, in 1775, was captain of a company of minute-men, serving in three campaigns in the war in the Fifth Company of Colonel Goose Van Schaack's Albany, N. Y., Regiment. No. 53.
- Waters, George J., Poseyville, Ind. Great-grandson of Jonathan Jaquess, who served five years in the Revolutionary

War—part of the time on land, part on sea—being a member of the Second New Jersey Regiment Light Dragoons, Colonel Sheldon. No. 112.

- Weadon, Frank Percy. Great-great-grandson of George Weadon, brigadier-general of Virginia Militia, Continental Troops, who, during the battle of Harlem Heights, had part of the hilt of his sword taken off by a ball. No. 29.
- Webster, George, Jr., Marion, Ind. Great-grandson of Joseph Webster, a private in Captain John Skimins's Company, Major Sheldon's Connecticut Regiment of Light Horse, marching October 23, 1776; discharged December 4, 1776. Accompanied Washington on his retreat through New Jersey in December, 1776. No. 151.
- Wheelock, William B., Ogdensburg, N. Y. Great-grandson of James Wheelock, Sr., who enlisted in January, 1776, from the town of Swanzey, N. H., under command of Colonel Timothy Bedel, regiment being ordered to join the Northern Continental Army with service in Canada, and performed ten months' actual service. No. 141.
- White, Michael D. Grandson of Nathaniel White, private soldier whose service is not shown. No. 37.
- Willson, Oscar J., Keene, N. H. Great-grandson of Aaron Willson, private soldier in the Continental Army, serving several months from July 16, 1776, in Captain Samuel Wetherbe's Company, Col. Isaac Wyman's Regiment, Vermont Troops. Also as a private in Captain Howlet's Company, which marched from Keene, N. H., to reinforce the Continental Army at Ticonderoga, June, 1777. No. 82.
- Wilson, John Randolph. Great-grandson of Richard Wilson, officer of Virginia Troops and a participant in the battles of Guilford Court-House and Yorktown. No. 34.
- Woodworth, Charles B., Fort Wayne, Ind. Great-grandson of Benjamin Studley, private in Captain Robert Lenthall Ell's Company, which marched on the Lexington alarm, April 19, 1775. Private in Captain Josh Sopers's Company, First Plymouth County Regiment, July 24, 1775. First lieutenant in Captain Winslow's Company, February 21, 1776. First lieutenant in Captain Stetson's Company,



Colonel Dyke's Regiment, December, 1776, to March 1, 1777. No. 63.

- Wysor, Harry R., Muncie, Ind. Great-grandson of Henry Wysor, sergeant in the Army of Virginia under command of General Daniel Morgan, and, at the battle of Saratoga, was one of five riflemen selected to make General Frazer of the British army the special object of their aim, shortly after which General Frazer fell mortally wounded. He was granted a pension from the fourth day of March, 1831, during his life. No. 71.

Constitution

ARTICLE I.

The name of this Society shall be "The Indiana Society of the Sons of the American Revolution."

ARTICLE II.

The Society shall be perpetual.

ARTICLE III.

The purpose of this Society shall be to perpetuate the memory of the men, who, by their services or sacrifices during the War of the American Revolution, achieved the Independence of the American people; to unite and promote fellowship among their descendants; to inspire them and the community at large with a more profound reverence for the principles of the government founded by our forefathers; to encourage historical research in relation to the American Revolution; to acquire and preserve the records of the individual services of the patriots of the war, as well as documents, relics, and landmarks; to mark the scenes of the Revolution by appropriate memorials; to celebrate the anniversaries of the prominent events of the war; to foster true patriotism; to maintain and extend the institutions of American freedom ; and to carry out the purposes expressed in the preamble to the Constitution of our country and the injunctions of Washington in his farewell address to the American people.

ARTICLE IV.

Any male resident of Indiana, over the age of twenty-one years, shall be eligible for membership who is descended, on either the male or female line, from an ancestor who assisted in establishing American Independence during the War of the

Revolution ; whether as a military or naval officer, soldier or sailor, or as an official or recognized subordinate in the service of any one of the thirteen original colonies or states, or of the national government, representing those colonies or states. No person lacking in these qualifications shall be eligible to membership in the Society.

ARTICLE V.

The officers of the Society shall be the President, Vice-President, Secretary, Registrar and Treasurer, who shall constitute the Board of Managers, a Delegate at Large and a Delegate to the National Society for each one hundred or fraction of one hundred exceeding fifty members: *Provided*, That the Society shall always be entitled to at least one Delegate at Large and one Delegate. The Society or its Board of Managers may also select honorary Vice-Presidents.

ARTICLE VI.

This Constitution may be altered, amended or repealed by a vote of two-thirds of the members of the Society present, at a regular meeting of the Society or at a special meeting called for that purpose, after proper notice has been given of such special meeting.

By-Laws

SECTION 1. Members shall be elected as follows: Candidates may send their names and documents, or other proofs of qualification for membership, to the Secretary; and upon a favorable consideration by the Board of Managers, shall upon payment of the membership fee and first annual dues thereupon become members of the Society.

SEC. 2. The initiation fee shall be two dollars and the annual dues two dollars. The payment at one time of fifty dollars shall constitute a life member, and the member so paying shall be exempt from the payment of annual dues.

SEC. 3. The annual meeting of the Society shall be held on the 25th day of February, the anniversary of the capture of Ft. Sackville, at Vincennes, Indiana, and in each and every year thereafter, at which a general election of officers by ballot shall take place, except when such date shall fall on Sunday, in which event the meeting shall be held on the following day, unless otherwise set by the Board of Managers upon due notice to the members. In such election, a majority of the ballots cast for any officer shall constitute a choice.

SEC. 4. At all meetings of the Society, five members shall constitute a quorum for the transaction of business.

SEC. 5. The President, or, in his absence, the Vice-President, or, in their absence, a chairman *pro tempore*, shall preside at all meetings. He shall preserve order and shall decide all questions of order, subject to an appeal to the Society.

SEC. 6. The Secretary shall conduct the general correspondence of the Society. He shall notify all members of their election and of such other matters as he may be directed by the Society. He shall have charge of the seal, certificate of incorporation, by-laws and records of the Society. He, together with the presiding officer, shall certify all acts of the



Society. He shall, under the direction of the President or Vice-President presiding, give due notice of the time and place of all meetings of the Society, and attend the same. He shall keep fair and accurate records of all the proceedings and orders of the Society; and shall give notice to the several officers of all votes, orders, resolutions, and proceedings of the Society affecting them or pertaining to their respective duties.

SEC. 7. The Treasurer shall collect and keep the funds and securities of the Society. They shall be deposited in some bank or savings institution in this State, to the credit of THE INDIANA SOCIETY OF THE SONS OF THE AMERICAN REVOLU-TION, and shall be drawn thence on the checks of the Treasurer for the purposes of the Society only. Out of these funds he shall pay such sums only as may be ordered by the Society or by the Board of Managers. He shall keep a true account of his receipts and payments, and at each annual meeting render the same to the Society, when a committee may be appointed to audit his accounts.

SEC. 8. If, from the annual report of the Treasurer, there shall appear to be a balance against the Treasurer, no appropriation of money shall be made for any object but the necessary current expenses of the Society until such balance shall be paid.

SEC. 9. The Registrar shall keep a roll of members; and in his hands shall be lodged all the proofs of membership qualification, and all the historical and geographical papers, manuscript or other, of which the Society may become possessed; and under the direction of such executive committee of the Board of Managers, shall, for adequate compensation, keep copy of such similar documents as the owners thereof may not be willing to leave permanently in the keeping of the Society.

SEC. 10. The Board of Managers shall judge of the qualifications of the candidates for admission to the Society and elect the same, and shall have charge of all the special meetings of the Society, and shall, through the Secretary, call special meetings at any time, upon the written request of five members of the Society, and at such other times as they see fit.

They shall recommend plans for promoting the objects of the Society, shall digest and prepare business and shall authorize the disbursement and expenditure of unappropriated money in the treasury for the payment of current expenses of the Society. They shall act as the Trustees of the Society and generally superintend the interests of the same, and execute all such duties as may be committed to them.

At all meetings of the Board of Managers three shall constitute a quorum for the transaction of business.

LOCAL CHAPTERS.

SEC. 11. Local chapters may be organized in any county of Indiana upon the application in writing to the Board of Managers of ten members of the Indiana Society, whose qualification for membership shall have been duly approved by the National Society. The selection of its officers and its mode of government shall be under the control and direction of such local chapter free of any outside supervision so long as the conduct of its affairs is in conformity with the Constitution and By-Laws of the National and State Society, of which it shall be a part.

SEC. 12. No amendment of the By-Laws shall be made unless adopted by a two-thirds vote of the members present at a meeting of the Society.
